#### *Expense-related allowances.*

- A. Pursuant to s 157 of the *Fair Work Act 2009*, the above award is varied as follows:
1. By deleting the amount “\$15.21” appearing in clause 19.2(a) and inserting “\$16.40”.
  2. By deleting the amount “\$0.91” appearing in clause 19.3(b)(iv) and inserting “\$0.95”.
  3. By deleting the amount “\$15.21” appearing in clause 19.5(b)(i) and inserting “\$16.40”.
  4. By deleting the amount “\$12.98” appearing in clause 19.6(a) and inserting “\$13.55”.
  5. By deleting the table appearing in 19.6(b) and inserting the following:

| <b>Year of apprenticeship</b> | <b>\$ per week</b> |
|-------------------------------|--------------------|
| Level 1 or 1st year           | 5.75               |
| Level 2 or 2nd year           | 7.42               |
| Level 3 or 3rd year           | 10.23              |

6. By deleting the amount “\$18.04” appearing in clause 28.7(c)(i) and inserting “\$19.45”.

7. By deleting the amounts “\$203.26”, “\$0.24”, “\$225.88” and “\$0.27” appearing in clause 28.7(d)(ii) and inserting “\$212.12”, “\$0.25”, “\$235.73” and “\$0.28” respectively.

8. By deleting the amount “\$0.91” appearing in clause 28.7(d)(vi) and inserting “\$0.95”.

9. By deleting the table appearing in clause C.1.2 and inserting the following:

10. By deleting the table appearing in clause C.2.2 and inserting the following:

| Use of own motor vehicle allowance—vehicle salesperson—Casual use of vehicle | 28.7(d)(vi)   | 0.95      | per km                    |

B. This determination comes into operation on 1 July 2023. In accordance with s 165(3) of the *Fair Work Act 2009* this determination does not take effect in relation to a particular employee until the start of the employee's first full pay period that starts on or after 1 July 2023.
