

The following ballot report is for B2023/1261 Protected Action Ballot conducted by TrueVote on behalf of Flight Attendants Association of Australia T/A Flight Attendants' Association of Australia. The ballot was live from 24/11/23 12:00 PM AEDT to 1/12/23 4:00 PM AEDT.


