Dear Vice President,

Re. AM2014/196 and AM2014/197 - Casual and Part-Time Employment - request for an extension of time

We refer to the above matters and the 'draft program for written submissions' published by the Commission on 9 March 2016. That draft program requires the filing of final comprehensive written submissions in reply in relation to the common claims by 5.00pm on 5 August 2016.

The Australian Industry Group (Ai Group) has made very extensive efforts to prepare our materials in accordance with this program but, regrettably, we will not be in position to file our materials today. Accordingly, we respectfully request a short extension of time to file our final comprehensive written submissions in respect of the common claims by close of business on Tuesday, 9 August 2016. Relevant considerations underpinning this request are addressed below.

As the Commission is of course aware, the breadth of Ai Group's interest in these proceedings is significant. Specifically, we have a substantial interest in the ACTU's claim as well as that mounted by the AMWU and AMWU - Vehicle Division, given the awards that those unions are seeking to have varied.

Final submissions by proponents of the common claims were due to be filed by 10 June 2016, however:

- The ACTU sought and was granted an extension of time to file its submissions by 17 June 2016. Its submissions were filed on 20 June 2016.
- The AMWU sought and was granted an extension of time to file its submissions by 17 June 2016. Its response to the Commission's Issues Paper was filed on 14 June 2016 and a further supplementary submission that deals specifically with the submissions filed by Ai Group on 26 February 2016 was filed on 17 June 2016.

Whilst we appreciate that a period of 6 - 7 weeks has passed since the filing of the aforementioned union submissions, Ai Group has been involved in a significant number of proceedings relating to the 4 yearly review of modern awards in the intervening period, which have collectively placed a serious strain on our resources.
