We refer to the above matters.

The SDA is seeking variations to the following four awards, which have been referred to the casual and part-time employment common issues Full Bench for determination:

- the Pharmacy Industry Award 2010;
- the General Retail Industry Award 2010;
- the Fast Food Industry Award 2010; and
- the Hair and Beauty Industry Award 2010.

The variations sought, in broad terms, relate to the entitlement of casual employees to overtime rates and related matters. The SDA filed submissions in support of its claims on 13 May 2016. It has not called any evidence.

The SDA's submissions in support of its claims were filed after the deadline set by the Commission in its directions of 29 June 2015 for the filing of material in opposition (that being 22 February 2016). Accordingly, the Australian Industry Group (Ai Group) has not yet filed material in response to the union's claims. Further directions for the filing of such material have not been issued. This matter was raised by Ai Group during proceedings before Vice President Hatcher on 5 August 2016. His Honour directed Ai Group to confer with the SDA and propose an agreed timetable (PN190 – PN196).

Accordingly, please find attached draft directions that address the above issue. We understand that the SDA consents to the issue of directions in the terms proposed.
