A. Further to the decision in [DECISIONREF] of the Fair Work Commission on [DATE] in AM2014/204, the *Health Professionals and Support Services Award 2010* is amended pursuant to s.156(2)(b)(i) as follows:

1. By deleting the existing cl.24.4, and inserting:

**“24.4 Physiotherapy practices**

In physiotherapy practices, the ordinary hours of work for a day worker will be worked between 7.00 am and 8.00 pm Monday to Friday and 7.00 am to 2:00pm on Saturday.”

B. This order commences from the first full pay period on or after [DATE].
