Introduction

- 1. The Australian Manufacturing Workers' Union (AMWU) makes the following Submissions to the Fair Work Commission in response to the directions in the Decision of the Full Bench 30 October 2017 [2017] FWCFB 5536¹.
- 2. These submissions relate to the AM 2014/247Sugar Award 2010.
- 3. The AMWU generally supports the submissions of the AWU to date in this matter.

Item 23 Hours of Work

- 4. The AMWU notes that the Clause 11.3 of the Exposure Draft refers to the alteration of the spread of ordinary hours of work by day workers by one hour at "either end of the spread".
- 5. This is one of a group of Awards containing similar ambiguous phraseology in relation to the alteration of the spread of hours. This Award should be considered at the conclusion of the Award stage of the Review in accordance with the decision of the Full Bench [2015] FWCFB 7236 at [159].²

Item 11 Facilitative Provisions

- 6. In our submission of 16 July 2016 we stated that the facilitative provisions were agreed between the parties. We note that the parties at this stage have been unable to confirm a written record of the provisions consented to. This is largely due to the change in the officers with carriage of the matters since July 2016.
- 7. We propose that the list of facilitative provisions be revisited to confirm what the respective positions of the parties are.

Item 42 Tool Allowance

8. The AMWU confirms that it will pursue a claim to insert a tools allowance for the apprentices in the Award.

Item 21 Overtime and Penalty rates

9. The AMWU supports the submissions of the AWU to date.
