The Dental Hygienists Association of Australia (DHAA) requests an extension to the due date for Item 2 of Vice President Catanzariti's Directions dated 18 May 2020, because the HSU filed their evidence objections yesterday afternoon Monday 25 May 2020. They were due 4pm on Friday, 22 May 2020.

The HSU have objected to the entirety of the DHAA's witness evidence from 11 witnesses (as attached). DHAA was relying on using the weekend of 23 and 24 May to speak to witnesses in relation to any objections raised by the HSU because the witnesses work clinically Monday to Friday. This was not possible due to HSU not filing on time on Friday afternoon.
