To the proper officer,

Deputy President Sams on behalf of the Full Bench of the Commission convened a conference earlier today in relation to matter AM2017/52 – Fitness Industry Award 2010 – substantive issues (notice of listing attached). The substantive issues referred to in this matter are the classifications definitions for the swim industry (items 17-28 in the [Summary of Submissions](#)).

Mr Procter of the Australian Swimming Coaches and Teachers Association indicated that the Australian Workers Union – Victoria Office ('AWU-VIC') previously held an interest in this matter. Deputy President Sams would like to know whether the AWU-VIC and/or the AWU National Office maintain an interest in this matter. If so, His Honour seeks an explanation of why the Union was not present at today's conference.

At the request of the parties today, the Deputy President proposes to convene a further conference to try to resolve the last outstanding issue in relation to the classification definitions. However, if the AWU wishes the matter to proceed direct to arbitration before the Full Bench His Honour will list a short phone hearing and set a hearing date convenient to the Full Bench. Of course, if the AWU has no further interest in the specific matters before the Full Bench, please advise accordingly.
