



## Schedule of revised draft determinations

### Common issue—Annual leave

The decision issued on 24 June 2016 in relation to the annual leave common issue [[\[2016\] FWCFB 3953](#)] finalised the model terms in relation to cashing out annual leave, leave in advance, EFT and annual leave payments and excessive leave for most modern awards.

In accordance with paragraph [46] of the decision, draft determinations varying modern awards to insert the various provisions identified in the table below have been amended and are published for comment. Parties are asked to comment only on the form of the determinations; not on whether a particular provision should be inserted into one or more awards nor the final wording of the model terms as set out in Attachment C to the decision.
