Dear Associate

I write in relation to the above matter, and with regard to the listing of the IEU's application at 4pm on Tuesday 24 April.

The production orders, which the IEU is seeking to have set aside in part on grounds of oppressiveness due to the volume of material they seek, are currently returnable on 25 April 2018. This is a public holiday.

Accordingly, it is likely that the companies the subject of the orders will have substantially advanced their compliance efforts, and some production may have already occurred. If the IEU succeeds in whole or in part, these efforts (and associated costs) will be wasted.

As such, I respectfully request that the time for production of the orders be extended to <u>4</u> <u>May 2018</u>, to prevent these wasted costs. This still leaves sufficient time for any material ultimately produced to be incorporated into the respondents' material.
