BACKGROUND

- 1. On 9 April 2021, Justice Ross, President issued a Statement¹ following the passage of the Fair Work Amendment (Supporting Australia's Jobs and Economic Recovery) Act 2021² ("Amending Act"). In short summary, the Amending Act introduced a number of amendments to the Fair Work Act 2009 ("FW Act") which deal, in part, with the rights and obligations of casual employees and their employers.
- 2. The Amending Act, amongst other things, requires the Fair Work Commission ("Commission") to undertake a review of modern award provisions as provided by clause 48 of Schedule 1 of the FW Act as amended ("Casual terms review").
- 3. Clause 48 of Schedule 1, provides:

48 Variations to modern awards

- (1) If:
 - (a) a modern award is made before commencement; and
 - (b) the modern award is in operation on commencement; and
 - (c) immediately before commencement, the modern award includes a term (the relevant term) that:
 - (i) defines or describes casual employment; or
 - (ii) deals with the circumstances in which employees are to be employed as casual employees; or
 - (iii) provides for the manner in which casual employees are to be employed; or
 - (iv) provides for the conversion of casual employment to another type of employment;

then the FWC must, within 6 months after commencement, review the relevant term in accordance with subclause (2).

- (2) The review must consider the following:
 - (a) whether the relevant term is consistent with this Act as amended by Schedule1 to the amending Act;
 - (b) whether there is any uncertainty or difficulty relating to the interaction between the award and the Act so amended.
- (3) If the review of a relevant term under subclause (1) finds that:
 - (a) the relevant term is no consistent with this Act as amended by Schedule 1 to the amending Act; or
 - (b) there is difficulty or uncertainty relating to the interaction between the award and the Act as so amended;
 - then the FWC must make a determination varying the modern award to make the award consistent or operate effectively with the Act as so amended.
- (4) The determination must be made as soon as reasonably practicable after the review is conducted.
- (5) A determination under subclause (2) comes into operation on (and takes effect from) the start of the day the determination is made.
- (6) Section 168 applies to a determination made under subclause (2) as if it were a determination made under Part 2-3.
- 4. On 14 April 2021, a Conference was held of interested parties.

- 5. On 19 April 2020, the Full Bench issued a Statement and Directions, including setting out draft directions.³ On the same date, the Commission issued a Discussion Paper⁴, including 3 attachments.⁵ The Discussion Paper poses 31 questions for consideration of the parties.⁶
- 6. A further Conference was held of interested parties on 22 April 2021.
- 7. On 23 April 2021, the Full Bench issued a Statement and Directions⁷ confirming the directions in the matter. The Directions require (as relevant to this stage of the proceedings):
 - 1. All interested parties to file submissions by 4.00pm (AEST) on Monday, 24 May 2021 responding to the questions in the Discussion Paper published by the Commission on Monday, 10 April 2021 and other matter the party wishes to raise. If a party is proposing a variation to one of the six Stage 1 Award then they should also file a proposed draft determination.

Note: The Commission staff will prepare a Submission Summary Document summarising the submissions in respect of each question posed in the Discussion Paper. The Full Bench will issue a statement publishing the Submission Summary Document and expressing some provisional views about the issues raised. It is anticipated that the

REVIEW TO BE CONDUCTED IN 2 STAGES

- 9. The Commission has determined to undertake the Casual terms award review 2021 in 2 stages has outlined in the Statement and Directions (19 April 2021)⁸:
 - [2] In short it was proposed that the Casual terms review be conducted in two stages:
 - 1. **First stage** a 5 member Full Bench will consider the nature and scope of Casual terms review and relevant terms in a small initial group of modern awards that raise a range of possible interaction issues. The Full Bench will then issue a decision on the outcome of its review and determine the process for the second stage.

The following initial group of 6 awards will be considered in the first stage of the Casual terms review (the Stage 1 Awards):

- General Retail Industry Award 2020
- Hospitality Industry (General) Award 2020
- Manufacturing and Associated Industries and Occupations Award
 2020
- Educational Services (Teachers) Award 2020
- Pastoral Award 2020

• Fire Fighting Industry Award 2020

2.**Second Stage** -a 3 member Full Bench (a subset of the 5 member Full Bench) will review the remaining modern award in convenient groupings.

[3] On 15 April 2021 a Conference was held to discuss the proposed approach. No substantive objections to the proposed approach were raised in the Conference...

- 10. With respect to the 6 modern awards in Stage 1, the CFMMEU MD has a direct interest in the *Manufacturing and Associated Industries and Occupations Award* 2020 ⁹("Manufacturing Award").
- 11. With respect to Stage 2, the CFMMEU-MD has an interest in the following modern awards:
 - Dry Cleaning and Laundry Industry Award 2020 ¹⁰ ('DC&LI Award')
 - Joinery and Building Trades Award 2020¹¹ ('Joinery Award')
 - Storage Services and Wholesale Award 2020¹² ('Storage Award')
 - Textile, Clothing, Footwear and Associated Industries Award 2020¹³ ('TCF Award')
 - Timber Industry Award 2020¹⁴ ('Timber Award')
