**C2019/52929 – Review of certain C14 rates in modern awards**

We refer to the above matter and to the Statement published by the Full Bench on 22 September 2023. Directions issued in that Statement invited interested parties to file:

1. Submissions in respect of the provisional view stated in paragraph [8] of the Statement;
2. Submissions as to the accuracy of the table at Attachment D;
3. Draft determinations or proposals for any specific award variations that might be necessary; and
4. Evidence upon which the party intends to rely.

The United Workers Union (**UWU**) has an interest in 22 awards as part of the extended scope of review. While UWU is in a position to file submissions in relation to directions (1) and (2) above, we are continuing to seek instructions in relation to a draft determination or proposal for the relevant awards.

We request an extension to file material in relation to directions (3) and (4) above until Friday 10 November 2023. We note that such an extension is unlikely to have an impact on the current timetabling for this matter.
