- 1. By deleting the amount "\$16.06" appearing in clause 18.3(a)(i) and inserting "\$16.39".
- 2. By deleting the amount "\$4.24" appearing in clause 18.3(a)(ii) and inserting "\$4.33".
- 3. By deleting the amount "\$16.06" appearing in clause 18.3(a)(iii) and inserting "\$16.39".
- 4. By deleting the amount "\$0.78" appearing in clause 18.3(b)(ii) and inserting "\$0.80".
- 5. By deleting the table appearing in clause 18.3(c)(iii) and inserting the following:

6. By deleting the amount "\$21.45" appearing in clause 18.3(c)(vi) and inserting "\$21.99".
